NEW AUTOMATED SYSTEM AVAILABLE FOR FILING FICTITIOUS BUSINESS NAME STATEMENTS AND DOMESTIC PARTNERSHIPS

Los Angeles County Registrar-Recorder/County Clerk (RR/CC) Dean Logan announces the implementation of a new automated filing system for filing Fictitious Business Names and Domestic Partnership filings. Effective April 4, 2011, the RR/CC will make available self-service public computer terminals for the public to file Fictitious Business Name Statements and Domestic Partnerships. The new system is available at the RR/CC Headquarters, 12400 Imperial Hwy., 2nd floor, room 2207B, Norwalk, CA 90650, Monday thru Friday, from 8 a.m. – 5 p.m. (excluding holidays).

RR/CC Dean Logan said, “This new automated system is another example of government working smarter while also providing easier, faster, quality services to our customers.” The public may now submit their document requests electronically using the Kiosk terminals to complete an online application. After reviewing and submitting the application, the applicant will receive a ticket validating the applicant’s filing request. Once the applicant presents the ticket to the cashier and pays the filing fee, the applicant must provide an original signature to complete the filing process.

“The new system offers the public the ability to file these documents on their own without the need to pay third party agent fees,” concluded Logan. Automated services include applications for New or Re-newing Fictitious Business Name Statements, Abandonments, and Withdrawals and Domestic Partnerships, Amendments, and Terminations.
