#### NOVEMBER 8, 2011 LOCAL & MUNICIPAL CONSOLIDATED ELECTIONS RESULTS CERTIFIED – RECOUNT REQUEST PERIOD BEGINS

Today Los Angeles County Registrar-Recorder/County Clerk (RR/CC) Dean Logan certified final election results for the November 8, 2011 Local & Municipal Consolidated Elections. Results will be publicly declared official by the Los Angeles County Board of Supervisors at tomorrow's Board meeting (Agenda Item #23). Election results were certified following a 10-day election canvass, which accounted for all ballots cast and included a 1% Manual Tally Audit of the results. The certification of election results marks the start of the Recount Request Period for any contest in the election.

The Recount Request period for this election will begin on November 22, 2011. Requests for a recount must be filed within five (5) days after the election has been certified (Elec. Code § 15620).

#### **PERIOD TO REQUEST RECOUNT:** (Elec. Code § 15620)

- **First day** a voter may request a recount of ballots: **Tuesday, November 22, 2011**
- **Last day** a voter may request a recount of ballots: **Saturday, November 26, 2011**

**NOTE:** Request must be filed with the Registrar-Recorder/County Clerk by Midnight on Saturday, November 26.

**REQUEST A RECOUNT:** (Elec. Code § 15620)

Any registered voter of the state may file a recount request; the request

- Must be in writing
- Must specify the contest to be recounted
- Must state on behalf of which candidate, slate of electors, or position on a measure (affirmative or negative) it is filed.

**PLACE OF FILING:** (Elec. Code § 15620)

With the county elections official responsible for conducting the election.

**NOTE:** *RR/CC will be closed during the Thanksgiving Holidays (November 24 - November 26). In Person requests may still be submitted during this period; up until 12:00 am on Saturday, November 26.*
