Maywood City Special Recall Election**

The Registrar-Recorder/County Clerk (RR/CC) will conduct a Special Recall Election in the City of Maywood on December 9, 2008. The purpose of the Special Recall Election is to submit to the voters within the City of Maywood the question of whether Ana Rosa Rizo, Veronica Guardado and Felipe Aguirre should be recalled as members of the City Council, and for the election of candidates to fill the vacancy for any office in which the recall prevails. In addition to the Special Recall Election, ballots will also include City of Maywood Special Election Measure M. (See attached sample ballot).

VOTE BY MAIL VOTING PERIOD

Applications to vote by mail may be filed now through December 2, 2008. Under special circumstances, a voter may request an emergency vote by mail ballot beginning Wednesday, December 3rd through Election Day, Tuesday, December 9th. Additional information regarding this service or any questions regarding vote by mail voting can be obtained by telephoning the Vote by Mail Section of the RR/CC at (562) 466-1323, between 8 a.m. and 5 p.m., weekdays.

VOTES NEEDED TO ELECT CANDIDATE

A majority of votes (50% + 1) is needed to recall. If recall prevails, the candidate with the most votes for any office in which the recall prevails is elected as successor for remainder of term.

VOTES NEEDED TO PASS BOND MEASURE

A majority of votes (50% plus 1 vote) is needed for passage of Measure M.
