Signatures submitted on in lieu petitions may also be applied to the signature requirements on nomination documents if signers are affiliated with same political party as candidate. The <b>supplemental petitions must be filed no later than March 1, 2010.</b> (E. C. §§ 8061 &amp; 8106 (b))</p>

C. §§ 8020, 8028 &amp; 10704)</p> <p><b>CANDIDATE STATEMENTS</b> During this period candidates for state legislative office agreeing to voluntarily limit their campaign expenditures may submit a statement for inclusion in the sample ballot. The statement shall not exceed 250 words and the estimated fee must be submitted by this date. (Govt. Code § 85601)</p>

(E. C. §§ 8600 &amp; 8601)</p>
<b>FEB. 16* (Tu)</b> E-56*		<p><b>SIGNATURE IN LIEU PETITIONS - DEADLINE</b></p> <p>Last day for candidates to file signature in lieu petitions. Candidates will be notified within 10 calendar days of filing the petition of any deficiency. Candidate may then, prior to the close of the nomination period, submit a supplemental petition or pay the pro rata portion of the filing fee to make up the deficiency. (E. C. §§ 8061, 8105 &amp; 8106)</p>

E-33	<p><b>PUBLIC EXAMINATION PERIOD FOR CANDIDATE STATEMENTS/CANDIDATE NAMES AND BALLOT DESIGNATIONS</b></p> <p>During this period <b>candidate statements, candidates' names and ballot designations</b> shall be open for public examination. A fee may be charged to any person obtaining a copy of the material. During this period any person may file a writ of mandate or an injunction to require any or all of the material to be amended or deleted. (E. C. § 13313)</p> <p><b>TRANSLITERATION REVIEW PERIOD</b></p> <p>First and last day candidates may review transliteration of their names. Requests for changes must be submitted to the county elections official no later than the last day of the review period.</p>

If any candidate receives a majority of all votes cast at the special primary election he or she shall be declared elected and the special general election shall not be held.

If no candidate receives a majority of votes cast at the special primary election, the name of the candidate of each qualified political party who receives the most votes cast for all candidates of that party shall be placed on the special election ballot as the candidate of that party. (E.C. § 10706)
