<b>MAR. 27 (F)</b> E - 88	<b>ADOPT SPECIAL MEASURE ELECTION RESOLUTION</b> Last day for governing board to adopt resolution calling special election and setting forth the specifications of the election order. Copies shall be filed with the Board of Supervisors and the Registrar-Recorder/County Clerk. <b>(Ed. Code § 5322)</b>
<b>APR. 1 (W)</b> E - 83	<b>AMENDMENT OR WITHDRAWAL OF MEASURE – DEADLINE</b> Last day for county elections official to receive a resolution from a legislative body requesting to withdraw or amend a measure previously submitted for placement on the ballot. <b>(E.C. § 9605)</b>  <b>MEASURE LETTER DESIGNATION</b> Last day for a district to request a specific letter designation in writing for a measure appearing on the ballot. An alternate choice should be submitted in case the requested designation has already been assigned.
<b>APR. 3 (F)</b> E - 81	<b>DATE FIXED TO SUBMIT ARGUMENTS – PUBLICATION</b> Not later than this date a notice shall be published once in a newspaper of general circulation in the district, setting forth the date fixed for submitting arguments for or against a county, school or district measure. <b>(E. C. §§ 9163, 9502 &amp; Govt. Code § 6061)</b>  <b>NOTE:</b> A copy of the published notice shall be delivered to the District Secretary/Superintendent and each notice shall be posted in the district office. <b>(E.C. § 12113)</b>

<b>APR. 7 (Tu)</b> <b>5 P.M.</b> E - 77		<p><b>ARGUMENTS – LAST DAY TO SUBMIT</b> Last day to file arguments for or against the measure. Arguments may not exceed <b>300</b> words in length. <b>(E.C. §§ 9501 &amp; 9502)</b></p> <p><b>EXCEPTION:</b> These provisions do not apply to a measure for school district reorganization.</p>
<b>APR. 8 (W)</b> E - 76	<b>APR. 17 (F)</b> E - 67	<p><b>PUBLIC EXAMINATION FOR BALLOT MEASURE MATERIALS</b> During this period the elections official shall make available for public examination a copy of the ballot measure text and arguments for the measure. A fee may be charged to any person obtaining a copy of the materials. During this period any person may file a writ of mandate or injunction to require any or all of the material/data to be amended or deleted. <b>(E. C. § 9509)</b></p>
<b>APR. 16 (Th)</b> E - 68		<p><b>REBUTTALS – LAST DAY TO SUBMIT</b> Last day for authors of arguments for and against a district measure to submit their rebuttals to the elections official. Rebuttals may not exceed <b>250</b> words in length. <b>(E. C. § 9500)</b></p> <p><b>IMPARTIAL ANALYSIS – LAST DAY TO SUBMIT</b> Recommended last day for County Counsel to transmit impartial analysis for measure to the Registrar-Recorder/County Clerk. <b>(E. C. § 9504)</b></p>
<b>APR. 17 (F)</b> E - 67	<b>APR. 27*(M)</b> E - 57*	<p><b>PUBLIC EXAMINATION PERIOD FOR REBUTTALS/IMPARTIAL ANALYSIS</b> During this period rebuttals and impartial analysis for the measure shall be open for public examination. A fee may be charged to any person obtaining a copy of the material. During this period any person may file a writ of mandate or an injunction to require any or all of the material to be amended or deleted. <b>(E. C. § 9509)</b></p>

<b>MAY 26* (Tu)</b> E - 28*	<b>JUNE 15 (M)</b> E - 8	<b>OFFICIAL SAMPLE BALLOT AND VOTE BY MAIL INSTRUCTIONS BOOKLET MAILING</b> Between these dates the Registrar-Recorder/County Clerk shall mail the Official Sample Ballot and Vote By Mail Instructions Booklet to voters. <b>(E. C. § 4101)</b>
<b>JUNE 8 (M)</b> E - 15		<b>REGISTRATION CLOSES</b> Last day to transfer or register to vote in this election. <b>(E. C. §§ 2102 &amp; 2107)</b>
<b>JUNE 9 (Tu)</b> E - 14	<b>JUNE 16 (Tu)</b> E - 7	<b>NEW CITIZEN REGISTRATION/VOTING</b> Between these dates any new citizen (a person who meets all requirements of an elector and has become a U.S. citizen after the 14 <sup>th</sup> day prior to the election but on or before the 7 <sup>th</sup> day prior to that election) is eligible to register and vote in the office of the Registrar-Recorder/County Clerk. New citizens must provide proof of citizenship prior to voting. <b>(E. C. §§ 331 &amp; 3500-3503)</b>
<b>JUNE 16 (Tu)</b> E - 7		<b>TALLY CENTER LOCATION – PUBLICATION</b> On or before this date a notice specifying the public place to be used as the central tally center for counting the ballots shall be published once in a newspaper of general circulation within the district. <b>(E. C. § 12109)</b>  <b>CANVASS BALLOTS</b> The canvass may commence on the 7 <sup>th</sup> day before the election but the results of the Tally shall not be released until election night. <b>(E.C. § 15001)</b>
<b>JUNE 19 (F)</b> E - 4		<b>REQUEST FOR A DUPLICATE BALLOT</b> Last day the Registrar-Recorder/County Clerk will send a duplicate/replacement ballot <b>in the mail.</b>  <b>NOTE:</b> Voters can pick up (and return) a duplicate/replacement ballot <b>in person</b> up to election day at the Norwalk office of the Registrar-Recorder/County Clerk.

<b>JUNE 23 (Tu)</b> <b>8 P.M.</b> ELECTION DAY	<b>ELECTION DAY – OFFICIAL VOTED BALLOTS RETURNED</b> Last day for ballots to be received (by mail or in person) by the Registrar-Recorder/County Clerk. <b>(E. C. § 4103)</b>
<b>JUNE 25 (Th)</b> E + 2	<b>CANVASS OF ELECTION RETURNS</b> The canvass of election returns shall commence no later than the first Thursday following the election. <b>(E. C. §§ 10547 &amp; 15301)</b>
<b>JULY 2 (Th)</b> E + 9	<b>COMPLETION OFFICIAL CANVASS</b> The official canvass must be completed within 28 days of the election. The legal deadline for County Elections Official to certify the election results is <b>July 21, 2009.</b> (E. C. § 15372)  <b>NOTE:</b> On <b>July 2</b> , the Registrar-Recorder/County Clerk is tentatively scheduled to certify the election results. On <b>July 7</b> , the Board of Supervisors is scheduled to declare the election results official.
