VOTING SYSTEM ADVISORY COMMITTEE CREATED TO WORK WITH REGISTRAR OF VOTERS TO HELP MODERNIZE COUNTY VOTING SYSTEMS

Today voting rights advocates, election officials, and representatives from the county's major political parties gathered in Norwalk for the inaugural meeting of the County's Voting Systems Assessment Project (VSAP) Advisory Committee.

The VSAP Advisory Committee is authorized by motion of the Los Angeles County Board of Supervisors, adopted on September 7, 2010. The Committee will work with the office of the Registrar-Recorder/County Clerk in establishing core principles that will help guide the County's efforts to modernize its voting systems.

The 15 member Committee includes experts, stakeholders, and community leaders representing critical constituency groups and communities of interest.
